- Cribs manufactured from **July 23, 2010 – June 28, 2011** may be consigned if the consignor provides a **Certificate of Compliance** from the crib manufacturer or retailer.
- Cribs manufactured **prior to July 23, 2010 will NOT be accepted under any circumstances.** Cribs that are unacceptable, for any reason cannot be sold as toddler beds.

The reasons for this decision is based on the new regulations and laws set by the Consumer Products Safety Commission.
